<ul style="list-style-type: none"> <li>• Revised ITP Loop #3 (10% - Due March 23)</li> </ul> <p>Students will complete ITP Loop #3 as per assignment in course outline. However, due to the inability to complete consultations in class, students will be required to participate in consultations via remote means. This might include: consulting with a classmate via phone; attending the optional zoom</p>		

session March 19 at 10:00am; arranging for an additional zoom session; connecting via D2L for consultation. - Exercise Leadership and Write Up (10% - Due: assigned dates)

For the students who did not have the opportunity to lead a group exercise in a face to face class; the instructor will work with them directly to identify an opportunity that is mutually agreeable to lead a group cohesion exercise virtually. To ensure equity, students expected to deliver the exercise virtually will receive support from the instructor to ensure students are not hindered by the use of technology or virtual format. Students will complete a write up and reflection as per course outline due 5 days after the exercise is delivered.

- Revised Professional Practice Framework – Written Component (35% - Revised due date: April April 3)

This assignment will be completed as per course outline. However, to ensure students are able to incorporate feedback from ITP Loop #3, the due date has been extended.

- Revised Professional Practice Framework – Capstone Presentation (25%)

This assignment will be revised to reflect a change in delivery format for the presentation. Capstones will no longer be delivered in -person on April 6 and 7. However, the assignment content and expectation remains unchanged and students have options for how they wish to delivery this presentation. Some options include, but are not limited to:

- A voice-over power point or prezi with audio component that is submitted to the instructor

- A zoom one-one presentation to the instructor
- Other formats presented and approved to the instruct
