<b>SYLLABUS STATEMENT</b>
---------------------------

UNIV 501.73 fosters applied learning and community practices within the contexts of Canada and Nepal. Focusing on critical and local community development approaches to knowledge and praxis, learners will engage with key concepts of social capital, empowerment, experiential learning and collaboration to enhance social justice.

<b>COURSE DESCRIPTION</b>
---------------------------

UNIV 501.73 engages learners in an applied field study of Nepal that begins with a critical examination of socio- economic and political climates of Nepal as it relates to community practice and social change. This course provides students with an introduction to theoretical and practical knowledge and skills to work with communities specifically marginalized and disadvantaged groups, in Nepal. Students examine current theories of community development and develop the skills necessary for effective social intervention at the community level with a special reference to Nepal. This course includes a local and global perspective and social issues related to environment and international development. This course will help students understand the relationship between community practice and structural change by exploring community engagement/community building approaches/activities and its applications for social change. This course teaches students about the nature of power and the social networks that it flows through, the skills and practices needed to mobilize diverse voices, and the ethics and values that guide social intervention with communities. The intent of this course is to introduce the idea of community practice as an alternative strategy to other forms of social service and social change.

<b>COURSE LEARNING OUTCOMES</b>
---------------------------------

Upon the completion of this course, students will be able to:

1. Students will be introduced to the history, knowledge and geo and socio-political contexts of Nepal.
2. Students will increase the understanding of social issues and social policies in Nepal.
3. Critically examine the social service delivery system in Nepal and its impact on how community services are delivered to urban, rural and disadvantaged and marginalized communities.
4. Demonstrate an understanding of the links between micro, mezzo and macro social work practice and how they all work collaboratively to create change.

5. Demonstrate an understanding of the dynamics of power in the community setting.
6. Demonstrate an understanding of the historical and current practices and tools used to mobilize communities.
7. Utilize practice skills used to overcome systemic barriers, and to promote human rights and social justice within diverse contexts and with diverse groups.
8. Describe Social Capital Theory, Assets Based Community Development, Participatory Action Research and Community Capacity Building.
9. Demonstrate the skills necessary to critically self-reflect in the community setting.
10. Demonstrate an understanding of how the neo-liberal and neo-conservative paradigms marginalize vulnerable communities.
11. Apply knowledge of community practice in both local and international settings.

## **ASSESSMENT COMPONENTS**

### **Assignment 1: Weekly Reflective Journal (20%) – Due May 6, 13 & 20 by 11:59pm (Mountain Time)**

Aligned Course Learning Outcome: 1, 2, 3, 4, 5

This assignment has 2 parts.

**Part I: Individual Reflective Journal 1 & 2 (Due May 6 & 13- each work 5%; total Worth 10 %).** This part I assignment encourages students to critically reflect on their learning from asynchronous sessions.

**Journal 1:** Please write your journal (maximum 500 words) focusing on the followings: (1) share how you are feeling now; (2) identify some of your significant learnings from asynchronous sessions (surprising/ disappointing/exciting/shocking); (3) share your expectations to learn in moving forward from this class.

**Journal 2:** Please write your journal (Maximum 500 words) focusing on the followings: (1) identify some of your significant learnings from asynchronous sessions; (2) share how this virtual learning stage is helping you in achieving your learning outcomes and critically understand local contexts/issues from a 'real life' perspective. (3) critique on methods/contents of this virtual learning sessions (share any challenges that you are currently experiencing in your learning about intercultural community practice at a virtual platform instead.

**Part II (Due May 20- worth- 10 %): Share your reflections in a video (7-10 min) considering** (1) what are the most key learning from this class; (2) how this virtual environment has impacted on your learning, particularity in the areas of intercultural and community practice (3) what questions do you have that remain unanswered? (4) what further learning will you need to do answer these questions; (5) how could we do differently to make this class more effective as it relates to students' learning?

**Assignment 2: Individual Assignment: Motivational Conversation Sharing (Maximum 10 minutes Virtual Presentation) (25%) – Due May 14 by 11:59pm, Mountain Time.**

Each student is matched with a community practitioner/activist/ educator living in Nepal for motivational conversations in a virtual platform. Then, students are invited to share their presentations in a synchronous session. Guiding Questions for the conversation and rubric for the presentation are posted on D2L site.

### **Assignment 3: Blog Post (15%) – Due May 18 and August 15 by 11:59pm**

This is not a long or intensive assignment. A couple of questions will be posted for students to respond on D 12 (Maximum 700 words for each question)

### **Assignment 4: Visual Research Project (40%)**

The Visual Research Project comprises of: 1. Group Research Presentation (worth 20%) and 2. Individual Written Report (worth 30%)

Aligned Course Learning Outcome: 8, 9, 10, 11

1. **Group Research Presentation:** The Visual Research Project is a group presentation (3-4 students) that invites students to incorporate primary research, field experiences and visual material to depict their chosen topic of the social issue and sustainable development in Nepal. Each group will provide a 15-minute presentation over Zoom (maximum 20 slides) on a chosen area of sustainable development that they experienced in Nepal. The project should link a key social issue in Nepal with one of the Sustainable Development Goals as defined by the United Nations. Integrate theoretical, experiential and reflective learnings within this presentation. The presentation should identify why the social issue and goal is important in Nepal and lessons learned during the exchange that could be applicable to Canada. The presentation should make explicit reference implications for social work practice in Nepal, Canada or globally. **Due May 22 (7 – 9 pm, Mountain Time)**

2. **Individual Written Research Project:** Students will provide the following content in their written component of the assignment (one document per team, max 30 pages (not including appendices, references, and cover page), in Word format – not PDF – double spaced, 12-point font. Students will need to clearly outline the social issue they were interested in and the community development approaches used in Nepal to address the issue and the relevant sustainable development challenge in relation to social work. How are they being addressed in Nepal, what is working, what is not working, how it could be applied in Canada, and its impact for social work practice. **Due June 15 Mountain Time**
