### Project Proposal (maximum 2,500 words)

#### Proposals should include:

- Brief background and rationale for the project
- A description of the project objectives and the gaps or unmet health needs it will address
- The population for whom the project is most relevant
- The impact the project will have on the population of interest
- A summary of the study design and methods used to achieve the objectives
- A summary of the knowledge translation or mobilization plan
- The potential to scale and spread the project's outcomes during and once the grant concludes

#### Project Budget and Timeline

Provide an estimate of the anticipated budget, including the proportion of funds to be allocated to overhead or indirect costs; the anticipated start date; and the estimated timeline for the project. The minimum project budget is \$500,000, up to a maximum of \$3,000,000. Funds may be expended over a period of 1 to 5 years. The budget and timeline may be adjusted at the Full Application stage if needed, but should remain within the required parameters of the funding call.

### Suggested External Reviewers

Provide the names, affiliations, and contact information for up to 10 suggested reviewers who could be contacted to review this proposal at the Full Application stage. You are encouraged to suggest a diverse list of potential reviewers with appropriate expertise to review and comment on the proposal.

Proposed reviewers should be experts from academia, research, nonprofit, philanthropy, the private sector, or the public sector, with no conflicts of interest with any member of the project team.
