SYLLABUS STATEMENT

This course explores the influences of public policy on the lives, relationships, and well-being of individuals, families, groups, and communities, while examining the relationship between social justice in the policy-making process and the role of social workers in creating and shaping policy.

COURSE DESCRIPTION

This course examines global and local social policy responses as they pertain to social work practice. Students will discover anticipatory policy-making processes, methods to influence policy, and tools for assessing policies. They will develop practical skills in strategy development and futures literacy capabilities. By critically analyzing practice through policy, equity, liberation, and anticipatory lenses, this course seeks to enhance and support further linkages between social work practice and social justice as integral to a holistic practice framework.

This course is delivered online via Desire2Learn (D2L) and Zoom. Weekly Thursday evening classes will be synchronous from 5:00 – 8:00pm Mountain Standard Time (MST), with an expectation to engage in additional learning asynchronously. Teaching methods to promote learning include instructor and guest presentations, readings, videos, group activities, discussions, and projects.

When unable to participate live due to the time difference or unforeseen circumstances, inform the instructor in advance and propose and implement an alternative participation activity (e.g., watch the recordings, submit a brief reflection).

Prerequisites: SOWK 600 and SOWK 602.

Upon completion of this course, students will be able to:

1. Identify how public policy influences and shapes people's lives and relationships.
2. Demonstrate a critical understanding of social policies in relation to the wellbeing of individuals, families, groups, and communities in Canadian and global contexts.
3. Assess and analyze essential features of a policy or policies that impact the service users they work with or have worked with in professional settings.
4. Examine how social workers, individually and collectively, can affect the policy process at the organizational, community, provincial or national levels.
5. Apply advocacy knowledge and skills to contribute to the development and implementation of new and more equitable social policies as it pertains to social work practice.
6. Develop innovation capabilities that applies futures thinking to social equity strategy development.

ASSESSMENT COMPONENTS

1. **Individual Assignment: Signal of Change (20%)**

Due Date: October 6, 2023 at 11:59pm

Aligned Course Learning Outcomes: 1, 5

Students will do an Internet search for a weak signal (specific example of something that suggests how the world is changing and how the future could be different). This signal can be a new technology, scientific breakthrough, a new law or regulation, start-up company, etc. that could impact the Future of Social Equity/Power/Social Justice/Liberation.

This Word (text) document will include:

- The name of the signal and the URL to the website/article that explains the signal
- A brief description of the signal
- The change this signal represents: from what (our present situation) to what (a possible future situation)
- The driver of this signal; i.e., the force behind the signal
- A brief and creative explanation of what the world could look like in 10 years if this signal gets amplified
- The student's opinion if this a possible future they/she/he wants and why

The assessment rubric for this assignment will be posted on D2L. Students will fill out a “Signals Template” in Word format that will be provided by the instructor on D2L. It will be a maximum of two pages, single sided, single spaced. This assignment will be submitted to the course’s Dropbox assignment folder.

2. Individual / Group Assignment: The Futures Triangle (30%)

Due Date: October 27, 2023 at 11:59pm

Aligned Course Learning Outcomes: 1, 2, 5

Individually or in groups of 2-4, students will complete a futures triangle as shown in class. The futures triangle will include:

- The pull of the future for the “centered” group(s) learned in the liberated futures lesson
- The weight of the past for the “centered” group(s)
- The push of the present for the “centered” group(s)

The document, in either Word, PowerPoint, or PDF format, will be a maximum of 5 pages, single sided, and single spaced. A minimum of 10 references, in APA 7 format are needed (e.g., journal articles, government reports, census and trends data, futurist websites, community-based policy documents, subject matter expert conversations, etc.). References can be listed on a separate page.

The use of plain language, infographics, and creative design and layout are encouraged for this assignment. The assessment rubric for this assignment will be posted on D2L. This assignment will be submitted to the course’s Dropbox assignment folder.

3. Individual / Group Assignment: A Social Equity Strategy (30%)

Due Date: November 24, 2023 at 11:59pm

Aligned Course Learning Outcomes: 1, 2, 4, 5, 6

Individually or in groups of 2-4, students will develop a “Social Equity” strategy for an organization or order of government. This strategy will be developed using one of the transformative anti-colonial / anti-oppressive futures lenses learned in class (ex. Afrofuturism, Indigenous futurism, Feminist futurism, Queer futurism, Disabilities futurism, etc.).

This strategy will include, but not limited to:

- Background:
 - A description of the liberated futurism used as a lens for the strategy (*centers an equity-deserving community*)
 - A summary of demographic data and issues faced by the selected equity-deserving community
- Definitions: Descriptions of key terms in the strategy
- The problem that the strategy is trying to solve/address
- The vision and mission statements of the equity strategy
- Anti-oppressive guiding principles + their descriptions
- Strategic focus areas with long term strategic outcomes
- At least one proposed action item or initiative for each strategic focus area

The document, in either Word, PowerPoint, or PDF format, will be a maximum of 10 pages, single sided and single spaced. A minimum of 10 references, in APA 7 format are needed (e.g., journal

articles, government reports, census data, futurist websites, community-based policy documents, subject matter expert conversations, etc.). References can be listed on a separate page.

The use of plain language, infographics, and creative design and layout are encouraged for this assignment. The assessment rubric for this assignment will be posted on D2L. This assignment will be submitted to the course’s Dropbox assignment folder.

4. Individual Assignment: Two Discussion Board Postings (20%)
Due dates: September 22 and December 1, 2023 at 11:59pm

Aligned Course Learning Outcomes: 1, 2, 3, 4, 5

Class attendance, participation, and required and recommended readings are essential components of this course. Consistent with the tenets of reflective practice, at during any time in the semester, students will be required to post two substantial insights from any of the class sessions or learning materials and how they might apply those insights to their personal social work practice and policy advocacy.

The two separate postings should be concise and focused on a specific topic learned in class. All discussion posts should be a minimum of 150 words and a maximum of 250 words. The assessment rubric for this assignment will be posted on D2L.
